

Terms and Conditions

Definition

These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you", "the purchaser") and Cellcolabs AB ("Cellcolabs", "we", "us", or "our"). Cellcolabs is registered in Sweden and have registered office at Retzius väg 8, Solna 171 65. These Terms and Conditions apply to all products produced by Cellcolabs, ordered either directly from Cellcolabs or through a reseller of Cellcolabs' products.

Pricing, purchases, and payment

Price is subject to change without notice. The list price does not include freight and packing or import duties where these are applicable during the purchase. Sales tax will be added to the price of purchases as deemed required by us. We may change prices at any time.

The purchaser agrees to provide current, complete, and accurate purchase and account information for all purchases, so that we can complete your transactions and contact you as needed. Unless otherwise agreed in writing, the purchaser shall pay 100% upfront after Cellcolabs confirmation of the order.

Cellcolabs reserves the right to correct any errors or mistakes in pricing, even if we have already requested or received payment.

All payments shall be in Euros. Cellcolabs accepts the following forms of payment:

Shipping

All orders from Cellcolabs are shipped through our recommended carriers unless an alternative agreement has been arranged with the purchaser. Applicable freight and handling charges will be added to the purchaser's invoice. If another carrier is specified, a carrier account number must be provided by the purchaser. Cellcolabs reserves the right to correct shipping fee any time before the purchaser receives the products.

Returns

Damaged or missing product must be reported within 5 business days after receipt of the product. Products may not be returned without first obtaining authorization from Cellcolabs.

Warranty and liability

All products sold from Cellcolabs will perform according to Cellcolabs' product specifications. Cellcolabs' warrants only apply in the circumstance which the specifications are not met. Product specification may be subject to change without notice. Cellcolabs will replace any product, free of charge that does not meet our established product release specifications. No recommendation is intended or should be construed as an endorsement of infringing a patent.

Cellcolabs is not responsible for any damages or injuries caused by the products. Additionally, Cellcolabs is not responsible for products after the expiration date, or for products that have been misused or have become unusable because of improper storage or handling.
